

Protect our communities from the most devastating harms of H.R. 1. The 2026 Anti-Hunger Package will feed millions of Oregonians and work to end hunger at its roots.

THE PROBLEM:

Oregon's hunger crisis is getting worse

Last July, Congress made the *largest cut to SNAP in history (H.R. 1)*: a devastating 30% reduction in funding. More than 342,500 Oregonians are expected to lose \$475 million per biennium in SNAP benefits.

Oregon redeems \$1.5 billion every year in grocery sales from SNAP. Cuts will hurt 3,500 Oregon retailers, as well as farmers and workers. Rural Oregon bears a disproportionate impact, as SNAP accounts for 30% of grocery revenue in Eastern and Southern Oregon.

Visits to food pantries across the state are up by 50% since 2023, and cuts to SNAP will worsen this crisis. H.R. 1 targets communities already facing heightened barriers to food, including:

- Legally present immigrants
- Older adults aged 55 to 64
- Parents of kids 14+
- Veterans
- Rural communities
- Unhoused families
- Families with high heating and cooling costs
- Former foster youth

THE SOLUTION:

Pass the 2026 Anti-Hunger Package

SCHOOL MEALS FOR ALL

School Meals for All would ensure all kids can eat breakfast and lunch at school, regardless of where they live. This would reduce child hunger, ease family grocery costs by \$1,400 per student each year and improve student academic and health outcomes.

OREGON'S FOOD ASSISTANCE NETWORK

To keep Oregon's Food Assistance Network afloat, Oregon must make a one-time allocation increase to the Oregon Hunger Response Fund. This will provide a crucial lifeline for the 1 in 7 Oregonians facing food insecurity who will rely on food banks even more with unprecedented cuts to SNAP. Currently, the gap to bring the system back into balance requires legislative action.

PRESERVE & STRENGTHEN SNAP

Oregon must preserve SNAP and protect the 770,000+ Oregonians who rely on SNAP to feed their families. This will help keep critical federal SNAP dollars flowing throughout Oregon. Food assistance can decrease a family's likelihood of eviction and improve education and health outcomes.

RELIEF FOR HUMANITARIAN IMMIGRANTS

Oregon must provide one-time relief for the thousands of Oregonians who lost SNAP due to H.R. 1's exclusion of humanitarian immigrants. These Oregonians are legally present humanitarian immigrants, such as refugees, asylees, humanitarian parolees and victims of severe trafficking.
